Federal Bank and a \$250,000 allocation from the Plutonium Settlement from our fabulous Aiken County Legislative Delegation, we were able to close on July 28 and began renovations this past Fall. J.M. Stewart Builders is our amazing contractor. Other partners such as Aiken Electric Cooperative, Savannah River Nuclear Solutions, Savannah River Mission Completion and Security Federal Bank have provided additional sponsorships to assist with renovations. We look forward to cutting the ribbon to the new facility in April and sharing the space with partner agencies and our community!



In 2022, we faced many challenges which resulted abundant successes. We kicked off our Annual Campaign on August 26th at the Family YMCA with a Star Wars themed event. Campaign Chair Heather Raynack, as Princess Leia, and her 2022 Campaign Cabinet exceeded its goal and raised over \$2.3 million. RUN UNITED returned and raised over \$35,000. 
COMMUNITY IMPACT

PV REPORT

In 2022 Project VISION partnered with amazing volunteers to provide critical home repairs to the low-income and disabled seniors in Aiken County. The program began in 1996 as a one-day service initiative for Savannah River Site employees. In 2008, what was once a one-day service program, became a full-fledged program that receives an annual United Way allocation to provide home repairs for low-income and disabled seniors.

Collaboration and partnerships are vital to the Project VISION Program!

In 2022, the program partnered with 8 volunteer assessors. They provided 92 hours of combined assessment hours and another 70 hours of repair time. Community Partnerships provided over 2,500 hours of service, accounting for over 90% of the total hours of service for the whole program! The largest annual partnership, Agency Day of Caring, engaged over 200 Savannah River Site employees. Volunteers provided repairs for 12 partner agency facilities and 4 Project VISION residential client homes. Lastly, we must highlight our partners who provided above normal financial contributions that helped offset the cost of lumber and other necessary materials for wheelchair ramp construction and home builds in 2022.

AFFINITY GROUPS

WOMEN UNITED is an affinity group of United Way of Aiken County and is based on a belief in the collective power of women to improve the lives of Aiken County's women and children. Women United is dedicated to transforming Aiken through active and specific philanthropic investments to tackle our communities challenges. Designated funds collected from fundraising activities are used to award grants that advance the health, safety, education, and economic status of Aiken County's women and children. Since 2016, Women United has awarded over \$128,000 in grants and provided thousands of items to our four shelters.



YOUNG PHILANTHROPIST SOCIETY

United Way of Aiken County's Young Philanthropist Society is an affinity group that strives to create a fun atmosphere that allows young donors to have the opportunity to give back to their community through volunteering and monetary contributions. In 2022, YPS assisted with a number of United Way events and programs including refurbishing Born Learning Trails, Be a Bunny, Run United, School Tools, Kickoff, and the Ghostly Gathering. The YPS Steering Committee hosted a day of agency tours as a way to help YPS members understand the needs in our community and how United Way of Aiken County and our partner agencies seek to meet those needs. Success By 6

Success by 6 is a collaborative initiative that acts as a catalyst in the community to ensure that Aiken County children get the best start in life by creating awareness of the importance of literacy, early childcare and quality education. Components of the initiative include three programs:

- The Dolly Parton Imagination Library is a research based program that promotes literacy and encourages families and children to read together.
- Bookworms is a volunteer based reading program created by United Way of Aiken County to encourage a lifelong love of reading in young children. The program partners with schools and childcare facilities to read to and with children. Bookworms was back in full swing in 2022 with volunteers reading weekly with a Millbrook Elementary kindergarten class.
- Born Learning Trail provide interactive, engaging outdoor activities that stimulate cognitive development, promote early literacy and encourage physical activity among children.
